Housing & Neighborhood Revitalization:

In 2008 Rebuilding Together Houston managed five home repair programs which restored/repaired, modified to safe, healthy living conditions 1,265 unduplicated homes/addresses of qualified low-income, elderly or disabled Houston homeowners and delivered attic insulation, energy star applicants, door/window replacements, caulking etc., to reduce energy consumption all at no charge to the homeowners served.

Volunteer Home Repair Program:

The Volunteer Home Repair Program (VHRP) facilitated completion of exterior home repairs by volunteers at 243 houses in 2008. On average, each house repair project utilized a 20-member crew which worked two Saturdays. The Company qualifies the homeowner, specifies the repairs to be completed by the sponsored volunteer crew and supplies the materials to complete the projects and the volunteer sponsor organization supplies the labor and tools to repair the home exteriors. Total value of donated labor was \$1,505,384.

Energy Efficiency Program:

In 2007 and 2008, Reliant granted RTH \$2,160,000 to deliver energy efficiency modifications to the houses of their qualified customers that were referred to RTH. In 2007 and 2008 CenterPoint Energy awarded RTH \$2,027,241 as a deemed savings grant for attic insulation and CFL bulbs. As of December 31, 2008 RTH had served 1,677 qualified houses with these grant funds.
